### Elllisville's New Wooden Factory

Our new manufacturing plant for making chair rockers, packing cases, etc., started up Monday and it is a daisy little enterprise. Messrs. Caldwell and Jordan furnished the capital and Mr. Knight is the promoter. They have already orders for enough chair rounds alone to keep the plant running for three months, the goods being shipped to the New England states. They pay \$5 per cord for round oak logs, but they must be sound and free of knots. This is the only saw mill of the kind in Mississippi. The saw is very fine, and the dogs are at end of the log instead of the side. There is considerable waste in timber, and the scarpage is sold at 50 cents per load, which is a cheap fire-wood. Mr. Caldwell says there is enough oak timber around town to keep the plant in operation for 25 years or more if people will bring it in.

One of three boys on roller skates is said to have been responsible for the breaking of the large glass at the Zepernick grocery, Central and Fifth Avenue, Friday night.

The incident marked the knocking over of a large weighing machine. This struck and broke the window, also broke the scales. A traveling man told Manager Archie Valentine of the grocery, that he was sitting in his car near by when the incident took place, that the boys were skating down Fifth avenue and in turning the corner, one of them "hugged" the machine in order to stop quickly. This threw the scales over, breaking the glass.

#### **Recipes**

**Sunshine Cake** 

1 cup butter

2 cups sugar

Cream the butter, adding the sugar a spoonful at a time until all is used

Beat the yolks of 11 eggs until very light and creamy. Beat them with the sugar and butter, adding the egg a spoonful at a time. Sift 2 ½ cups of flour with 2 ½ teaspoonfuls of baking powder, and the flour a little at a time, alternating it with one cupful of milk, flavor with 1 teaspoonful of vanilla. Bake in a loaf until done.

## **Apple Snow**

Steam three large tart apples and rub them through a sieve. Beat the whites of three eggs until stiff, add ½ cupful of sugar and beat again. To this meringue add the apple pulp and beat lightly. Dot with jelly and serve.
