



New Railroad Being Built
Will Connect Ellisvilel With Town of
Kola.

Now Laying Rails West Of The River
Twelve Mile Gap to Be Closed Up
Before Fall Season When Regular Trains May
be Put On. Opens Fine Territory

Work was resumed Monday morning on the Ellisville and Kola Railroad, which will extend twenty five miles due west from Ellisville to Kola on the G.&S.I. railroad. The road is already completed from the city to Leaf River, a distance of twelve miles. A big steel bridge, on of the most substantial in the state, was recently completed across that stream, and construction from the western terminus of the road was well under way when the financial crisis came in the fall of 1897. The remaining nine miles of the road will now be speedily constructed and train service between Ellisville and Kola will be possible by the beginning of the next fall season.

The new road was begun by the Ellisville Lumber Company before its large plant in this city burned. The same company owns a large mill at Kola and has millions of feet of fine virgin pine timber in the territory traversed by the line. Mr. Mulferd Parker, chief shareholder and dominant factor in the company, is one of the far-seeing business men of this section, and is preparing to meet the tide of prosperity now set in this direction.

It is his intention to complete the new road from the river to his Kola mill at the earliest possible moment and there is every indication that the Ellisville mill will be rebuilt and in operation before another year.

The Ellisville and Kola Railroad is not a zig-zag, tramway affair. On the contraty it is a real railroad, comparativley straight and much better than many of the lumber roads in this section which have developed into great commercial highways.

The territory between Ellisville and Kola is capable of splendid development. The farm lands are above average and yield abundantly when intelligently cultivated. Some of the best farmers in South Mississippi reside in the western part of the county and tese will offer ever encouragement to the new road.

The News expects to see the Ellisville and Kola railroad develop into an important feeder to the trade of this city.

"uncle Billie" as he was so fondly called, was a pioneer citizen of Ellisville having lived there nearly thirty years. For the past year, he had been in very ill health and part of the time a very great sufferer.

Mr. Freeman was a member of the Bapriat Church and always attended when health permitted.

He is survived by four sons, Clifford Freeman, of Fayetteville N.C., Jim Freeman of Laurel, Ed Freeman of Wausau Camp and Claude Freeman of Hattiesburg. Three daughters, Mrs. Joh Bethea of Columbia, Mrs. Leslie Devall and Mrs. Jimmie Hunt, both of Eillisville. A number of grand children and one sister, Mrs. W. J. Burnside of Ellisville, and one brother, Thomas Freeman of Alabama also survive.

Mr. Freeman was 69 years old. The funeral will be held from the First Baptist Church. The hour has not been set pending arrival of his son from North Carolina.
